

It is easy for things to get confusing and complicated when transferring assets into an LLC. The federal paperwork is notoriously complicated, and even if you do manage to get through it, you will still have to complete the state and local paperwork. This often results in unforeseen tax requirements, which can slow the process immensely. It might actually be cheaper and easier to process your conversion as a merger with the LLC instead of a conversion, leaving the LLC as the surviving entity. The other option is to do a ÄfÄçÄ ¨Ä “statutory conversion,ÄfÄçÄ ¨Ä • which is when a corporation is not legally dissolved before it is converted into an LLC.
