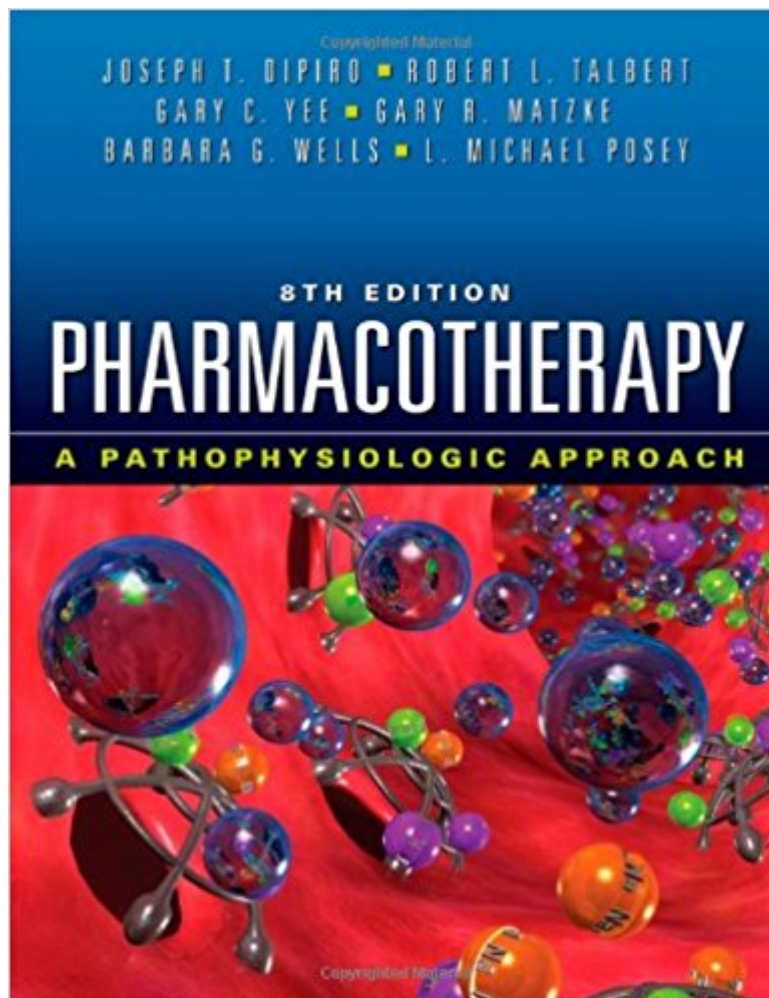

I bought this to update from my 7th edition. What a waste of money. The first 13 chapters only give a one page summary and tell you to go to a website to be able to read the chapter. This also occurs for several chapters throughout the book. I went to the website and as of now, it doesn't work. Why did I pay for the book if I'm going to have to go to a website to read it or print it off? The chapters that are in the book are nearly identical to those in the 7th edition. I've gone through about 4 or 5

chapters and they are exactly the same. The other issue is the low quality paper. The paper is like newsprint. It's difficult to read because the printing on the other side can be seen through the paper. You cannot highlight at all because it soaks right through the paper or rips the paper. The 7th edition was so much better.

No page numbers! Really? My assigned reading is by page number, not chapter. A textbook publisher should anticipate this when making the electronic version. Especially if they want over \$100.00! This is the first kindle book I've bought, and I didn't realize that I needed to check if it came with page numbers that match the print edition. I am terribly disappointed that my only choices for this book are a giant 20lb monster or no page numbers!

I have just received a copy of 8th edition from . This is not a review of the content (which from past editions, I am sure is excellent), but rather of how the book is physically put together. With the 8th edition, there are more than 2668 (8.5 X 11 inch) pages all bound together in one volume, and the text margins are way too tight towards the spine of the book....and this forces the reader to read text on highly curved pages, or to "dig" for text that is pinched down towards the spine of the book. The book I received would be much more reader-friendly if its contents were printed over multiple volumes, or if a larger page size had been used along with more accommodating margins.

If you're looking for this text, odds are that you're a pharmacy student. Congratulations! Your professors probably told you you need to buy DiPiro's at some point during your educational career. I haven't used it as much as they'd like to think I do, but it really is **THE** go to reference for pharmacotherapy (and even some pathophysiology) questions. I purchased both the full-sized textbook as well as the handbook, which is my recommendation for you. The full-size text contains A LOT of information that won't be included in the handbook, which makes it a great desk reference when you're working on a case. However, for quick and dirty work with most major disease states, the handbook is my go-to source. It pares down all the excess and leaves you with tables and flowcharts that simplify disease state management as much as is reasonably possible. And yes, it [the handbook] will fit comfortably in a lab-coat pocket, so I imagine it will be joining me on my clinical rotations in the future.

I'm a nurse practitioner student and this book was used in my advanced pharmacology course. I do agree that the pages in this book are cheap and thin. I've torn a few pages just by turning them or

posting a tab on them. However, this is the most complete pharmacology book and most certainly the easiest to understand. I've owned many books including Goodman's and Gilman's from whom I was told by a pharmacist that it was their "bible". I've learned more about treating patients, diagnosing, and information about drugs than most other books combined. I love how this book actually splits up every disease or disorder. It covers epidemiology, pathophysiology, pharmacological and even nonpharmacological treatment. Even though this is a cheap book, and yes the first 13 or so chapters are online, I will keep this book as my "go too" for my pharmacological questions. I should note....this book is massive, heavy, and must be lifted with both hands.

This is the only textbook I see myself holding onto after school. It is a great therapeutics book for anyone. We use it often for all of my pharmacy therapeutic classes. The book reads easy and the chapters are all organized and structured the same way. A really easy to use and great book. Not wordy and full of lots of good tables for treatment algorithms and side effects of drugs. Glad I bought it.

This book contains tons of information that we use in our advanced pharmacology class. I like the fact that I can access some, not all, chapters of this book via the internet & that I do not need to carry it in class all the time. The downside is that not all chapters are accessible on line and that the book is too heavy to carry around in my backpack/bag. The pages are very thin that it made them fragile that even a little tug could potentially tear them. I have already a small tear on one of the pages the first time I opened the book. It would be nice to just have an account that you can access the entire book online so I can read it from my iPad & not deal with the quality of paper the publication company used in this book.

This book is a great reference and has helped me, as a student, better understand topics that my teachers have taught me. Additionally, the convince of not having to carry around this VERY heavy book is definitely a plus. However, there are some major flaws in the electronic version. First, it doesn't have pages. This wouldn't be terrible if it offered x-ray so I can see what chapter I'm in, but it doesn't. Also, when reading the book, I can go to the next page and it will skip some of the material. When I try to go back it's skips to a few pages before the one I just came from and the text has been rearranged. These downfalls make it hard to determine whether I should have just gotten the hard copy instead.
