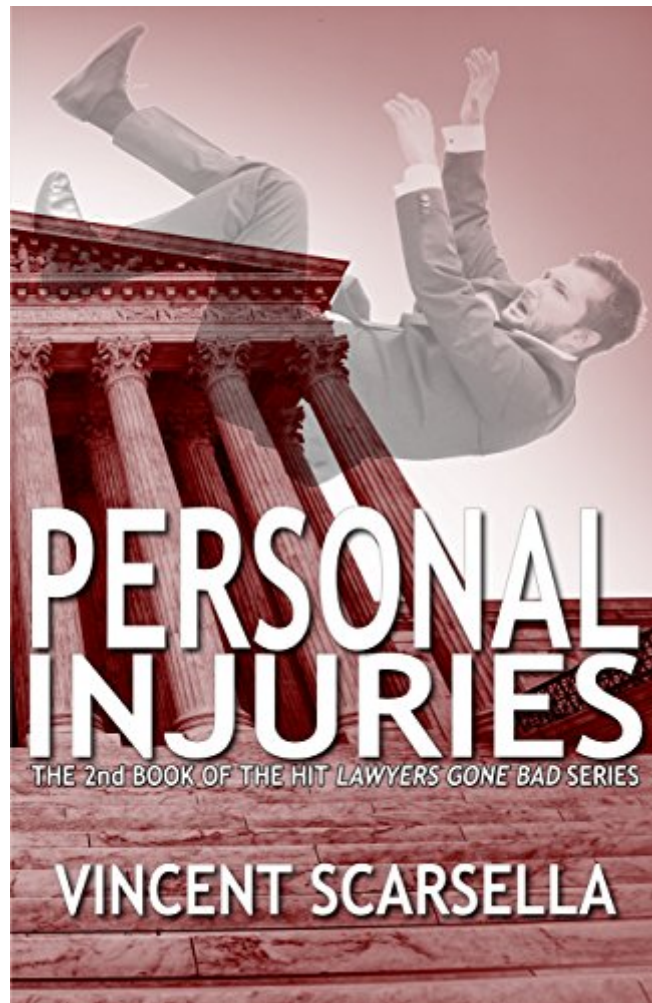

I have rarely enjoyed a book more than this one, and I look forward to the next in this series.

Well, I'm shocked -- shocked! that there are personal injury lawyers who improperly build cases. More shocking yet: there are doctors who help them!! This investigation of a single law firm could apply to the whole personal injury industry.This and the first book are well developed stories that would be more believable if they weren't so wide-eyed -- as if the legal profession isn't rife with people taking shortcuts, manipulating information and colluding with one another.What is accurate, though, is the degree to which the legal profession has protected itself from scrutiny. New York is typical in restricting any public information about attorney discipline, and allowing incriminating information to become public and available for prosecution is considered a violation of the ironically termed "lawyers' ethics." In this case, the Chief Justice of the state supreme court has suppressed evidence of lawyers who are responsible for multiple murders. And the guy who can fix it would, at the very least, lose his law license if he tried to do so.Such is the state of justice when it involves lawyers.

"Be careful what you wish for," and "No good deed goes unpunished," are two popular quotes referred to by characters in this book often. And they really kind of sum up the book! When good lawyers and legal teams tangle with BAD lawyers and the mob, you just KNOW you're in for a wild

ride. I know this is the second book in a series, but it works well as a standalone novel. The characters are believable--some of them likable, some of them downright despicable! As they struggle through personal lives and cases/a law firm that lead them in dangerous and unexpected situations, it remains believable throughout. And there is sometimes moments of hilarity that just made me laugh out loud. And a twist ending just leaves this reader wanting more! Overall, I'd rate character development at around a 4 (but again, remember this is book 2, and the main characters may have already been introduced and more developed in book 1, so a reader already familiar with them and know them a little better than this reader). Storyline, I would give a five, because the pace doesn't slow down at all, and kept me engaged and entertained the whole way through. In some ways, I got frustrated, because just like in the real world, the bad guys don't always get their full due, and you just have to accept that. But those bad lawyers? Ooooooh, I wish I was judge and jury!!!! I think if word of this book could get around more, it could possibly be a bestseller. I know I want more, and certainly going to read the first book, Lawyers Gone Bad just because of how much I enjoyed this one. This book gets a 5 star rating from me because not once did it lose focus, and it kept moving ahead like a steamroller. It is left wide open for a third installment, which I will look forward to reading. These lawyers (the good guys) just keep pushing forward, not letting letdowns or losses get them down.
