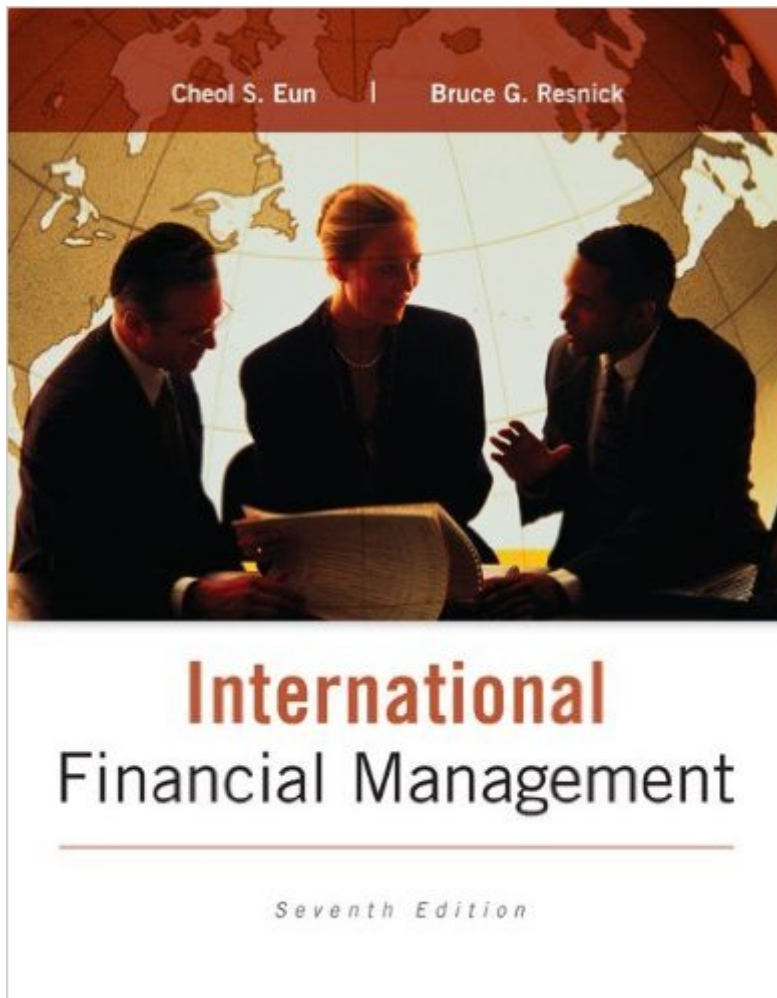

He serves as a consultant to national and international organizations, including the World Bank and the Korean

Development Institute, advising on capital market liberalization, global capital and exchange risk management. Bruce Resnick, Wake Forest University. Bruce G. Resnick is the Joseph M. Bryan Professor of Banking and Finance at the Babcock Graduate School of Management of Wake Forest. He has also taught at Indiana University, the University of Minnesota, California State University and at the Helsinki School of Economics. Professor Resnick has served as resident director of the Center for European Studies at the University of Limburg in the Netherlands. His research interests include efficiency of options and futures markets and empirical tests of asset pricing. A major focus is the optimal design of internationally diversified portfolios controlled for parameter uncertainty and exchange rate risk. In recent years, Professor Resnick has investigated international portfolio investment strategies applying information in the yield curve. His research has been published in major academic journals in finance. Bruce Resnick is an associate editor for the Journal of Financial Research, Journal of Multinational Financial Management and the Journal of Economics and Business.
